What is the Employee Pillar of Character Award?

Everyone has an outstanding co-worker in their office – someone who stands out as an exceptional role model. The United Way of Martin County Employee Pillar of Character Awards was created as a way to recognize these individuals. The Employee Pillar of Character Award is presented to employees throughout Martin County who consistently demonstrate one or more of the six character traits that are the cornerstone of CHARACTER COUNTS! – Trustworthiness, Respect, Responsibility, Fairness, Caring, and Citizenship.

Nominating someone is a great way to boost morale and show your appreciation for their commitment to exemplifying good character and work ethic within your organization.

BUT WE CAN'T RECOGNIZE THEM UNLESS YOU NOMINATE THEM!

It's Easy to Nominate Someone:

- Complete the one page information cover sheet.
- Then, in 1,000 words or less, explain how the employee demonstrates good character, work ethic, and at least one of the Six Pillars of Character: Trustworthiness, Respect, Responsibility, Fairness, Caring, and Citizenship.
- Finally, provide a letter of recommendation from someone other than you, the nominator, so we know why you believe they are deserving of this recognition. Be sure the letter addresses the nominee's good character and work ethic.
- Include the nominee's name on all pages of the application including the letter of recommendation.
- **Eligibility:** To be eligible, individuals must be employed in Martin County, Florida and cannot have been a previous recipient of an Employee Pillar of Character Award within the last five years. United Way of Martin County Board members, CHARACTER COUNTS! Advisory Board members, and employees of United Way of Martin County and our project sponsor, Cleveland Clinic Martin Health, are ineligible.
- ***Up to ten outstanding employees will be recognized at their place of business in March!***
